Approve an ordinance amending City Code Chapter 4-8 (Regulation of Lobbyists) to revise the definition of “City Official”, require that information related to direct communications with City officials be reported in activity reports; modify the requirement to disclose certain communications with a City official, remove the requirement of city departments or offices to provide a reporting method, remove the exception for written disclosures to the City department or office, and revise the information for City auditor review. Funding: Available in the Fiscal Year 2025-2026 Operating Budget of Management Services.

3. Authorize negotiation and execution of a Place-Based Enhancement Cultural Preservation economic

development agreement with The Vortex for a total amount not to exceed \$107,803 over a five-year term to support retention of this local legacy creative sector business. Funding: \$20,715 is available in the Fiscal Year 2025-2026 Operating Budget of the Austin Economic Department's Economic Incentive Reserve Fund. Funding for the remaining years of the agreement is contingent upon available funding in future budgets.

St. John Avenue (formerly 7309 and 7211 N IH-35) to update the Concept Plan, provide deeper affordability, and other terms as further outlined in a term sheet. Funding: \$66,667 is available in the Capital Budget of Austin Aviation. Funding for the remaining contract term is contingent upon available funding in future budgets.
9. Authorize a contract for channelizer posts and barricades for Austin Transportation and Public Works with Houston Barricade and Supply LLC, for an initial term of two years with up to three 1-year extension options in an amount not to exceed \$3,500,000. Funding: \$340,278 is available Operating Budget of Austin Transportation and Public Works. Funding for the remaining contract term is contingent upon available funding in future budgets.
10. Authorize a contract for one-inch river rock for the waterline bedding material for Austin Water with Community Trucking LLC, for an initial term of two years with up to three 1-year extension options in an amount not to exceed \$1,500,000. Funding: \$175,000 is available in the Operating Budget of Austin Water. Funding for the remaining contract term is contingent upon available funding in future budgets.
11. Authorize a contract for VOX books for youth collection for Austin Public Library with Library Ideas, LLC dba Library Ideas, for an initial term of one year with up to four 1-year extension options in an amount not to exceed \$450,000. Funding: \$46,667 is available in the Operating Budget of Austin Public Library. Funding for the remaining contract term is contingent upon available funding in future budgets.
12. 13.
